## MAXIMUM WATER VOLUME

### PER INHABITANT PER DAY

The total volumes of water that

enter the municipal reservoir for

the population's supply must not

exceed 230 liters per

inhabitant per day (including economic

and commercial activities).

POOLS - Filling pools is prohibited:

- No pool may be filled under any circumstances (public, private, or other types). This

limitation applies to all water sources

(drinking water,

wells, or other intakes, tanker trucks,

etc.).

- Partial filling of pools with water recirculation systems is allowed, in the quantities necessary to guarantee the water's sanitary quality.

- In educational centers, the complete or partial filling of demountable pools with a capacity of less than 500 liters for the bathing of infants is permitted.

- These limitations do not apply to seawater pools that are filled and emptied without connection

to public supply and sanitation networks.

IRRIGATION - Irrigation of green areas and public and private gardens is prohibited, except:

- For survival irrigation of trees or plants. This survival irrigation must be done with the minimum amount of water

necessary, from 8 p.m. to 8 a.m., and only by drip irrigation or sprinkler.

Lawn irrigation is prohibited in all cases, except on surfaces intended for federated sports practice, where irrigation

may be maintained in the minimum quantities necessary to allow it, without exceeding the maximum allocation of 450 m<sup>3</sup>/ha/month and

complying with any other limitations set by the local authority.

- The prohibition of irrigation in exceptional circumstances does not apply to irrigation with rainwater collected from roofs or with water

regenerated from sewage treatment plants.

CLEANING of streets and urban furniture

- Cleaning with drinking water of streets,

sewers, pavements, facades, and similar surfaces, whether public

or private, is prohibited except if the cleaning is

the result of an accident or fire, or if there is a sanitary or safety risk

road. In these circumstances, cleaning will be done

with the minimum amount of water necessary.

- Cleaning of shop windows and windows with a bucket and sponge is allowed.

VEHICLE CLEANING - water use is limited to:

- Cleaning in commercial establishments dedicated to this activity that have water recirculation systems. Outside of these establishments, only cleaning of windows, mirrors, rear-view mirrors, lights, and license plates with a sponge and bucket is permitted.

- Cleaning of vehicles outside of commercial establishments to maintain the safety and health of people and animals is allowed. This includes vehicles for food transportation, transportation of animals (alive or dead), ambulances, medical vehicles, and transportation of medicines and waste. It will always be done with the minimum water usage possible.

#### ORNAMENTAL FOUNTAINS

The total or partial filling of ornamental fountains, artificial lakes, and other elements of aesthetic water use is prohibited, except for artificial lakes that support aquatic life, where the minimum use of water necessary for maintenance is allowed. The relocation and/or concentration of affected aquatic life to an environment that ensures its maximum survival with minimal water consumption must be studied and, if feasible, carried out.

#### ELIMINATION OF AIRBORNE DUST

The use of water for the elimination of dust and suspended matter in the air is prohibited.
